New Bedding Plants: Add 1 fl. oz. concentrate per each 1 gallon water. Apply once per week directly to soil as a root drench. Diluted mix can be applied directly over plant, will not harm foliage. Use 5-10-5 full-strength, undiluted when applying via a hose-end-sprayer.

Indoor and Tropical Plants: Mix 0.5 fl. oz. of concentrate per gallon water and apply evenly to soil areas surrounding plants. Repeat application process at every watering event. More mature indoor plants, mix 1.0 to 1.5 fl. oz. per each 1 gallon water and apply as a soil drench.

Trees, Vines and Berries: Add 2.0 to 4.0 fl. oz. of concentrate per each 1 gallon of water and apply to plant as a root drench. Where necessary it can be applied directly over plant, will not harm foliage.

Caution: Keep out of reach of children. May cause irritation of skin and eyes. If spilled on skin, rinse with water. In case of contact with eyes, flush with water for at least 15 minutes.
